

# **REMINDERS FROM THE OFFICE**

**2024 Membership Dues Invoices -** Invoices were mailed on 12/04/2023. If you have not received your 2024 invoice, please contact Lana Thomas at the office for assistance.

**Notary Services** - We would like to extend the service of a Notary to our Circle D Civic Association Members. If you are ever in need of a Notary, please call the office and make an appointment.

**PayHOA Contact Information** - Contact information such as email, phone numbers, or mailing address needs to be current in the members' PayHOA account. This is so we may be able to contact members and send notices. If you do not know how to change this information in your PayHOA account, please call the office and we will change it for you.

**Deed Restriction Reminder** - Due to the recent influx of deed restriction complaints in regard to loose animals, the Compliance Committee would like to remind the members of Circle D to keep animals confined to your property, as loose animals are a deed restriction violation. (Read in blue below)

Members may submit deed restriction violation complaints to contactus@circledbastroptx.org. Include the address or section and lot number of the property that is being reported, a description of the violation, and any pictures that may help with the investigation. Complainants' will remain anonymous.



**All Sections General Restrictions, Paragraph 2** - "(2) . . . . . . . . . All parcels on which animals are kept must be adequately fenced so as to keep said animals confined to that parcel."

The Compliance Committee would like to advise members that in the event of an aggressive animal or animal bite, the Bastrop County Animal Control and the Bastrop County Sheriff's Office should be contacted to make a report. CDCA does not have any authority over animal bites, only the deed restriction that animals must be contained to your property.

It would be ideal to contact the property owner and try to work out the loose animal issue between neighbors, but if contacting your neighbor does not solve the issue, contact the CDCA Office and Bastrop County Animal Control.

# **CDCA PARK NEWS**

The Park Chair, Mark McNeese, and the park employees have been busy working on items concerning the park.

- There have been 35+ dead trees removed due to the lack of rain last summer.
- Regular mowing has resumed.
- The brush pile was burned when it was safe to do so.
- Broken playground equipment has been removed and the ground filled in for safety.
- The lake level had remained low for a while, but with the recent rain, we have measured at least 4 inches of rainfall in the lakes.
- The committee is looking into a large awning to cover the playscape to provide shade.
- There is a 2024 projected plan being drawn up to address the repairs that need to be made in the park, such as new signs and painting the pavilion.

SECTION 4.1: Number. The affairs of this Association shall be managed by a Board of seven (7) directors, who must be members of the Association in good standing. State law prohibits the Association from preventing a delinquent member from running for the board, but does not prevent the board from requiring the individual to become current in order to serve.

**Board of Directors** 

SECTION 4.2: Term of Office. The number of directors constituting the Board of Directors of the Corporation is seven (7), of whom four (4) directors shall be elected biennially for a term of two years and three (3) directors shall be elected for a two-year term in the intervening years.
